	ater District No. 7, Rogers County, Oklahoma, hereby water service(s), and if water service is made available by

- Purchase or cause to be purchased one benefit unit for each water service at the unit price of \$1300.00.
- 2. The funds paid for Benefit Units shall be considered donations to the District and shall in no event and under no circumstances be refunded to the subscriber.
- 3. Pay a minimum monthly meter charge for water for each water service from the time service is made available by the District, and pay for additional water used at the rate set out in the rate schedule adopted by the Board of Directors. Any changes made in the minimum monthly water charge and rate schedule by the Board of Directors of the District shall become a part of this agreement as though fully set out herein.
- 4. The Member agrees to grant to the District, its successors and assigns, a perpetual easement in, over, and under and upon the described land, with the right to erect, construct, install, and lay, and thereafter use, operate, inspect, repair, maintain, replace and remove water pipelines and appurtenant facilities, together with the right to utilize adjoining lands belonging to the Member for the purpose of ingress to and egress from the described land.
- The tract(s) to which each benefit unit is to be assigned and specifically described as situate in the State of Oklahoma, to-wit:

- 6. The water service supplies by the District shall be for the sole use of the undersigned; the undersigned agrees that he will not extend or permit the extension of pipes for the purpose of transferring water from one property to another, nor will he share, resell or sub-meter water to any other customer. Each meter service shall supply water to only one residence or business establishment located on dwelling or piece of property within the District. If service is for business purposes, the district will require applicant to provide an estimate of water consumption.
- 7. If after water service is made available the same is discontinued or disconnected for any purpose, pursuant to the by-laws and rules and regulations of the District, reconnection shall be upon the conditions set out in the by-laws and the rules and regulations of the District.
- 8. The undersigned agrees that they will make no physical connection between any private water system and the water system of the District. Representatives of the District may at any reasonable time come on the premises where the water is being used for the purpose of making inspection to enforce this provision. Violation of the provision shall be grounds for disconnection of service.
- 9. The laws of the State of Oklahoma, the by-laws of the District, and the rules and regulations of the District, as presently existing, and as may be amended from time-to-time, are made a part of this agreement as though fully set out herein.
- 10. I the undersigned, have read, understand and hereby agree to the afore going conditions in the Water Users Agreement set forth by Rural Water District No. 7, Rogers County, Oklahoma., and By-Laws, Rules and Regulations established by the Board of Directors
